BARBARA R. PORTER, EXECUTIVE DIRECTOR RECEIVES NASBA AWARD



The National Association of State Boards of Accountancy (NASBA) works to enhance the effectiveness of the country's 55 state boards of accountancy. At its Annual Meeting in Nashville, Tennessee, on October 25, NASBA presented awards to honor individuals for work in furthering its mission.

Barbara R. Porter was presented with NASBA's prestigious 2011 Lorraine P. Sachs Standard of Excellence Award. Established in 2008, the Standard of Excellence Award was established to recognize state board Executive Directors that have shown exemplary, dedicated and outstanding service and commitment to improving the effectiveness of accounting regulation, both locally and nationally.

Throughout her career with the Idaho Board, Ms. Porter has consistently demonstrated leadership, vision and commitment to the regulation of the accounting profession in a way that preserves integrity and protects the public interest. Ms. Porter is credited for possessing an uncanny ability to deliver exceptional results with limited resources. Her "do more with less" spirit has proved successful as she spearheaded collaborative partnerships with individuals and organizations in order to leverage winning outcomes. Additionally, she empowered her staff to identify and groom volunteers to assist with the Board's CPE, Peer Review Oversight and Investigative Committees.

The Board's engagement of volunteers has resulted in highly-productive committees, created a pool of highly-knowledgeable applicants from which to recruit board members and sparked a greater involvement of Idaho Board members on NASBA Committees. Ms. Porter has served NASBA in numerous capacities, including both appointed and elected positions. She is a Past Chair of NASBA's Executive Directors Committee and she has served on several NASBA committees in the last fifteen years, as well as three years on the AICPA Board of Examiners.

Save and Logout allows you to record courses throughout the year until you are ready to submit your final CPE Report.

Click Next if you have entered all your CPE courses and are ready for final submission or to request an extension.

You can enter your courses throughout the year. When you complete your entry for the year, print a copy for your records, and submit your report. It goes directly into the Board's database.

Once you click "SUBMIT", you will see the phrase "Your CPE data has been submitted." Before exiting this screen, take a screen print as your confirmation of timely submission. ...continued on next page

Idaho requires licensees to maintain copies of their CPE Reports for 5 years.

After you click Submit, you are no longer able to access this year’s form. The next time you log into the CPE Reporting system, you will be accessing next year’s reporting form.

A significant benefit to you, the licensee, is that you know your CPE meets your requirement prior to submitting your report. You are also provided with the number of CPE hours you will owe for the upcoming year.

We had hoped to rework our online system this year so that spreadsheets containing your CPE information could be imported. Unfortunately our developers were not able to make a universal application that would accept a variety of different spreadsheets. This means you will need to transfer information if your courses have been recorded in another format.

All licensees are asked to utilize the online system. **The Board is no longer able to accept hard-copy or emailed submissions.**
