Disciplinary Actions by the Board

Judith McKetta CP-2707
Moscow, Idaho

Ms. McKetta performed audit services for a client in South Dakota. She did not have a license or practice privileges in South Dakota, nor was she registered in Idaho to perform attest services. Ms. McKetta entered into a stipulated consent agreement for a letter of reprimand, a \$1,500 fine, \$650 in cost recovery, and will not perform attest services without appropriate firm registration and Peer Review.

Wayne Hamblin CP-3991
Salmon, Idaho

Mr. Hamblin issued audited and reviewed financial statements without a CPA license or a firm registration. After reinstating his license, he continued to perform these services without undergoing pre-issuance review and peer review as mandated by Board order. Mr. Hamblin's license is suspended for two years and he is fined \$6,500.

Shannon Stith CP-4943
Boise, Idaho

Before Ms. Stith became an Idaho licensee, she was CFO for publicly traded company. The SEC alleged she had a role in a fraudulent press release that artificially inflated the value of the company's stock. She did not disclose the situation in initial CPA Exam and licensure applications, which violated the Accountancy Act and Rules. The Board ordered a letter of reprimand, ethics CPE hours, and fines and fees of up to \$1,500.

Robert Thurston CP-1800
Twin Falls, Idaho

Mr. Thurston's CPA license was suspended in April 2009. However he continued to trade on the CPA designation by having: "Certified Public Accountant" on his office door; his CPA wall certificate on the wall of his office; a phone book listing as a CPA; and filed tax returns with the CPA title. The courts granted injunctive relief requiring Mr. Thurston to discontinue such practices. Mr. Thurston's license remains suspended. He removed the CPA designation from his business and paid \$2,000 in fines.

Jonathan Gibbs CP-2863
Emmett, Idaho

Mr. Gibbs agreed he violated the Idaho Accountancy Act and Rules when his office released reviewed or audited financial statements that were not prepared in accordance with professional standards. The Board ordered a reprimand, \$3,500 in fines and fees, and restricted his license from performing any services that require peer review.

Once you have completed all CPE courses for the current year, type your name at the bottom, print a copy and click SUBMIT. You will immediately see a red sentence appear on the screen "*Your CPE data has been submitted.*" – PRINT another copy of this page immediately for your CONFIRMATION. You must click on File Print before closing this screen as you will not be able to access this page again. To further confirm you have submitted the 2011 CPE report, log back into the system.

CPA Exam Score Release Fourth Testing Window October—November 2011

Starting with the *fourth testing window (October/November) in 2011*, scores will be reported with more predictability and frequency than the pre-CBT-e score release schedule. Under this improved score release schedule, CPA Exam scores will be released to NASBA following the first month of testing in a window, with subsequent score releases every two weeks for the remainder of the window.

In addition, with very few exceptions, candidates who test early in a window will be eligible for the first round of score release.
